



## PURCHASING NAVAL AVIATION/BLUE ANGELS MERCHANDISE

The emblems, crests, symbols, insignia, devices, names, logos, words, and colors of Naval Aviation represent time-honored qualities and service to the Nation. The name, script, paint scheme, and emblem of the Navy Flight Demonstration Squadron (Blue Angels®) are among the Navy's most famous and legally recognized trademarks. Aviation squadron emblems, and insignia such as Wings of Gold, are other examples of marks uniquely associated with the U.S. Navy. The Secretary of the Navy has established a Department of the Navy Trademark and Licensing Program (Secretary of the Navy Instruction 5870.7), in order to protect these trade and service marks. Any royalties in excess of program costs go to the Navy's official Morale, Welfare, and Recreation Program.
